ORDER GRANTING AMENDMENT TO BOND ORDER


Upon consideration of the Defendant's Motion to Amend Bond Order filed February 12, 2004, and the State's response to same, the Court finds that the trial in the Federal Multi-District Litigation matter of In Re: Tri-State Crematory Litigation filed in the United States District Court, Northern District of Georgia, Rome Division, being Case No. MDL-1467, will be held in Rome, Georgia, and is scheduled to begin on March 1, 2004, and continue until its completion; and further that it is estimated that the federal trial will last four to six weeks.

IT IS HEREBY ORDERED that the Defendant is granted permission and allowed to stay in hotel accommodations in Rome, Georgia, from February 29, 2004, until the conclusion of the federal trial of In Re: Tri-State Crematory Litigation filed in the United States District Court, Northern District of Georgia, Rome Division, being Case No. MDL-1467, accompanied by Attorneys Stuart James or Frank Jenkins during the evening hours, in addition to the

previously ordered provisions when the Defendant is in the company of his criminal defense attorney McCracken Poston.


